The following terms and conditions may please be read and understood before submitting the tenders.

**Terms & Conditions**

1. The tenders not sealed or not in the enclosed proforma or not accompanied with EMD or received after due date and time will be summarily rejected. While sending tender, it must be clearly indicated on the envelope TENDER FOR DISPOSAL OF OLD, OBSOLETE AND UNSERVICEABLE ITEMS-2016-17
2. The tender must be sealed and accompanied with an earnest money of Rs.10,000/- (Rupees ten thousand only) in the form of Demand Draft/ pay order drawn in any Scheduled Bank for each unit in favour of Managing Director, Odisha State Seeds Corporation Ltd., Santarapur, Bhubaneswar payable in the SBI, Old Town Branch Bhubaneswar.
3. The tenderer is required to quote his rate as indicated in the Price Schedule. In Annexure-1.
4. The tenderer can apply unit wise/item wise tender as per the item list at Annexure-I

5. The conditional tender will not be accepted on any circumstances by the authority.
6. No intending tenderer is permitted to furnish his tender in his own manuscript papers.
7. The time for completion of the lifting the unserviceable machinery/item will be 30 days from the date of Agreement.
8. On as is where is basic without guarantee, measurement, weight and numbers.
9. The items are listed in Annexure-A with this document.
10. The offered purchase price should be mentioned in Indian currency, both in figures and in words in the format enclosed separately.
11. The purchase price is to be offered for all the items in one lot irrespective of number in the enclosed proforma of FINANCIAL BID at Annexure-B Cost offered in part will not be accepted. In exceptional circumstances Managing Director reserves the right to accept part offer (not for all the items in Annexure-I) with the recommendation of disposal committee.
12. The EMD shall be forfeited if the tender resigns from his offer whatever reasons.
13. Tender form filled in pencil, overwriting, illegible or erased will not be considered.
14. Tender will be opened on 28.04.2017 at 3.00 PM. The interested tender or his authorized representative can participate in it.
15. The successful tender will have to make full payment by Bank Draft/Net Banking in favour of Managing Director, OSSC Ltd, within 15 working days from the date of communication and before execution of Agreement Order failing which EMD will be forfeited.
16. The successful tender immediately after making full payment referred to Para 1 above shall take delivery of the items in one lot irrespective of number within 30(thirty) days and make the area, where these are kept, clean and clear.
17. The successful tender shall take away the items on his risk & cost and he shall be responsible for safe and appropriate use/disposal of the items.
- 18.** In case of any dispute, the decision of the Arbitrator to be mutually decided by both the parties.
19. The EMD of the unsuccessful tenders shall be released without interest after successful tender takes possession of the unserviceable items.
20. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
21. The earnest money will be refunded to the unsuccessful tenderers within 60 days after finalization of the tender process.
22. The successful tenderer will have to make their own arrangement for lifting the stock from the different places within 30 days from date of execution of the Agreement.

23. The tenderer whose tender is selected shall be intimated to deposit entire cost of the machinery as per his quoted rate and failure to deposit the same within 15 days shall entail forfeiture of the Earnest Money.
24. The successful tenderer will be responsible for payment of all taxes and duties, all labour and machinery charges for lifting, shifting, loading and transporting out of the campus the unserviceable machinery.
25. The tenders received will remain valid for a period of 120(one hundred and twenty) days from the date of receipt of tenders and validity of tender can also be extended if agreed to by the tenderer and the Corporation.
26. All taxes including Sales tax, ferry, tollage, conveyance charges and other costs on account of land and building including temporary building required by the tenderer for housing of staff or other purpose of the work have to be borne by the successful tenderer.
27. Compensation including cost of any suit for injury to/ death of persons, damages to property any sums which may become payable due to operation of workmen's Compensation Act shall be the responsibility of the successful tenderer.
28. The parties will enter to agreement with the embodied terms and conditions shall be deemed to have been entered into at Bhubaneswar and the Court at Bhubaneswar alone will have the jurisdiction in such matter. Neither party shall be entitled to file any proceeding in any other Court of Law.
29. The successful tenderer shall take away the items on his own risk & cost and he shall be responsible for safe and appropriate use/disposal of the items.
